BE IT FURTHER RESOLVED: That the Secretary/Treasurer of this chapter be and he is authorized to certify to said Credit Union a copy of these resolutions and the names and signatures of this chapter's officers authorized to sign drafts as provided in these resolutions, and said credit union is hereby authorized to rely upon such certificates until formally advised of any changes therein.
